The undersigned is directed to say that the State Govt. in the Education Department after due consideration of the application of the Jermel's Education Trust for the State Government's No Objection for its affiliation, with the C.B.S.E., Delhi, hereby accords 'No Objection' to the Jermel's Academy, 52, Rash Behari Sarani, Hakimpura, Siliguri-1 for its affiliation with the C.B.S.E., New Delhi, subject to the following terms and conditions :-

1. The State Govt. will not bear any financial liability for the school at present or in future.
2. The School will not enhance tuition fee without prior approval of the State Govt. in writing.
3. 10% of the new admission in the school each year will be allowed on the recommendation of the School Education Deptt. and 50% of such recommended students will be allowed to prosecute studies in the school, free of any fees.
4. The school will pay its teaching and non-teaching staff, emoluments at a rate which will not be less than those of their counterparts with equivalent educational qualifications in State aided Educational Institutions of this State.
5. The school will pay its teaching and non-teaching staff G.P.F. in the scales as prescribed under the relevant Provident Fund Act/rule of the Govt. of India.
6. Violation of any of the conditions laid down in sub-para 3 to 5, shall entail withdrawal of this N.O.C. of the State Govt. with effect from the beginning of the next academic year.

This issues in cancellation of this Department's letter No. 1028-Edn(S) dated 14.12.92 according to 'no objection' to this Institution for its affiliation with the I S C E Council.


